

Schindler - Legal Terms and Conditions

These terms and conditions refer to the website www.schindler.com/uk.html (the "Site"). All access to and use of this Site is governed by these terms and conditions, together with the additional terms referred to within it such as our Privacy Policy and our Cookie Policy (the "Terms and Conditions").

The Site is operated by Schindler Ltd (United Kingdom) ("we" or "Schindler"). We are registered in England and Wales under company number 00662746. Our registered office and main trading address is at Benwell House, Green Street, Sunbury on Thames, Middlesex, TW16 6QS. Our VAT number is 286101078.

1. Access and Acceptance

By entering or accessing the Site, including browsing or registering, you (either "user" or "you" in this document) accept, without limitation or qualification, these Terms and Conditions.
